
To Survive, Humanity Needs to Remove and Reduce ("R/R") GHG/Heat in the Atmosphere

# Global Climate Catastrophe: China Must Save the World to Save Herself

Q: Why Does Humanity Face Extinction in 25 Years?

A: Capitalism's "maximize shareholder profit" mentality is the root cause of Climate Catastrophe. Since the Industrial Revolution, all global economic activity maximizes profit for the benefit of only one stakeholder (Shareholders). Humanity (even in socialist countries) teaches these values in schools. This motivation excludes balanced ethical considerations, social equity, equality, fairness and benefits sharing of all other interests including the environment and global sustainability. Humanity must transform its economic model and deployment of capital by using a new mentality, systems and tools that prioritize R/R in the next 25 years and balances all stakeholder interests, promotes benefits sharing and delivers the benefit of the social contract to all the people.

Industrial Revolution

W: Governments massively subsidize the fossil fuel industry (USD7T/Year). Financiers (Banks, Investors, Insurers) deploy (lend, invest and insure) capital that drives Businesses (Companies/Supply Chains) to use dirty energy to generate GHG/Heat, which is trapped in the atmosphere and increases global warming. Governments', financiers' and Business's profits are 100% aligned with fossil fuel profits. Instead of transitioning to zero-carbon energy sources, the continued reliance on fossil fuels increases GHG/Heat equivalent to 365 million Hiroshima bombs each year contributing to the Climate Overshoot. **Governments, Financiers and Business** must transform their operations towards zero-carbon SOPs, keep fossil fuels in the ground and deploy all their resources and capital towards R/R.

X: Humanity mistakenly believes that achieving Energy Transition and Net-Zero/Decarbonization is Humanity's Safe Harbor. The fossil fuel industry and their Cooperators (Governments/Financier) promote an "Illusion of Solutions" to distract, delay, obstruct climate solutions. Removing and Reducing ("R/R") of all accumulated and new GHG/Heat must be the laser-focused goal of humanity. Nothing else matters.

Y: Humanity is not safe after achieving energy transition and decarbonization. Carbon Looping, Tipping Points, Carbon Bombs and Wars, excluded from the net zero model continue warming the planet. GHG/Heat and Climate Overshoot continues to rise until we reach "Terminal Velocity" of rising GHG/Heat and Peak/Cap before a downturn begins. This will not happen naturally. This requires immediate human intervention, and the combined efforts of nations, industry, universities, experts, financial industry, professors, NGOs to successfully develop technology to R/R accumulated and new GHG/Heat.

Z: The economic system profiting on fossil fuels is killing Humanity. For Humanity to be safe, it must successfully complete Energy Transition ("W"), achieve Decarbonization/Net-Zero ("X"), Cap, Peak and Turndown of GHG/Heat ("Y") and deploy massive amounts of zerocarbon energy to power the (existing/new) technologies necessary to R/R to reach Safe Harbor ("Z")

### **Solutions for the Current Climate Catastrophe**

To Reach Safe Harbor, Humanity Must Focus on the Following 3 Goals:

1. Implement Massive Geoengineering Solutions With Existing and New Technology to R/R GHG/Heat

Use Dr. Kings 4Rs (Former UK Chief Scientist and Chair of the Cambridge Center for Climate Repair):

- 1. Reduce Emissions
  - Replace all fossil fuels with zerocarbon sources
- 2. Remove Emissions
  - Use existing and new technologies to remove accumulated GHG/Heat from the atmosphere to decrease global temperature
- 3. Repair Ecosystems
  - Restore degraded ecosystems damaged by the overshoot
- 4. Strengthen Resilience Against Climate Impacts
  - Prepare communities to withstand the unavoidable effects of Climate Catastrophe to save lives

2. Transform Behavior and Operations of Governments, Businesses and Capital Deployers from Maximizing Profit (Old) to Implementing New Mentality, Systems and Tools that Prioritize Zero-Carbon Energy, R/R and the 4Rs by Balancing All Stakeholder Interests (New)

- i. Governments (Subsidies Granters)
- ii. Regulators and Regulator's Implementers

### Practical Solution Tools to Achieve the 3 Goals and R/R

Practical tools, based on a new value system, for all Ecosystem Stakeholders to transform their operations to achieve R/R of GHG/Heat when implementing the 4Rs:

#### "Dharma Codex"

- 440+ sustainability criteria are the basis for Governments to design compliance systems that empower Businesses and Financiers to successfully R/R GHG/Heat.
- By using new inclusive values, causes balanced benefits sharing and no exacerbation of social inequalities or environmental injustices.

#### • Strategic Plans

- Develop 1-3-5-year strategic plans for all Ecosystem Stakeholders to achieve R/R
- Empower ecological stakeholders to increase the trajectory and velocity of capital flow and expand global market access by prioritizing R/R initiatives.

### Sustainability and Resilience Training

o Implement training for all stakeholders across all levels of leadership and operating departments (directors, officers, supply chain, HR, finance) to enhance climate literacy and to implement R/R and 4Rs Framework.

#### • Cooperation of Subject Matter Experts

- Engage subject matter experts to guide stakeholders (Governments, Financiers and Businesses) to transform systems and operations to improve on all 440+ sustainability criteria over time
- Create actionable SOPs for achieving R/R and implementing the 4Rs effectively.

## Support the Massive Rollout of Zero-Carbon Energy

- Support the planetary roll-out of all types of renewable and nuclear energy to power the existing/new technologies necessary to R/R GHG/Heat in the atmosphere to reach Safe Harbor.
- Support Project Ubuntu which focuses on deploying baseload, scalable, zero-carbon small modular reactors globally to reach Safe Harbor as soon as possible.
